The following documents must be submitted with this application:

1. Original Export Pedigree issued by the Kennel Club of the country of origin. ** (The applicant must be the registered owner of the dog in the country of origin.)
2. Airway bill
3. Import Permit
4. Quarantine Document

The Original Export Pedigree must be submitted within 6 months from the original date of application, or the application will be rendered Null and Void. There shall be no refund of application fees.

** In cases where the application for Original Export Pedigree has already been submitted with the country of origin, a photocopy of the Certified Pedigreed OR any document(s) indicating the name of the imported dog must be submitted with this application. Otherwise, the application will not be accepted.
